Byron, MN Four years no-till plus cover cropping have produced excellent results on Martin’s farm. Also works closely with farmers at Olmsted County SWCD.

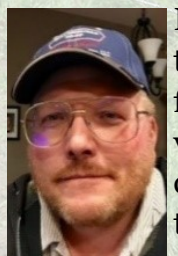
JON LUHMAN
