IN ADDITION TO ONETOONES, LSP INVITED STAFF, BOARD, AND MEMBERS TO FORUMS ON LAND ACCESS, SOUGHT RECOMMENDATIONS FROM ALLIED PARTNERS, AND DRAFTED A VOLUNTEER ROLE DESCRIPTION FOR STEERING COMMITTEE PARTICIPATION THAT WAS CIRCULATED VIA ITS NETWORKS. AFTER A ROUGHLY 1YEAR PROCESS, LSP RECRUITED A 12MEMBER STEERING COMMITTEE THAT IS INTENTIONALLY DIVERSE IN TERMS OF AGE, CLASS, RACE, EXPERIENCE IN LAND OWNERSHIP/LAND ACCESS, EXPERIENCE IN LAND TRANSITION/RETURN, AND PROFESSIONAL AND PERSONAL EXPERIENCE.
